DEED TO W. D. Walkman et al

KNOW ALL MEN BY THESE PRESENTS, That Muller Realty Company,

a corporation chartered under the laws of the State of South Carolina.....and having its principal place of business at Greenville.....in the State of South Carolina.....for and in consideration of the sum of One Hundred Dollars and other valuable Consideration....DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee....hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto W. D. Walkman

and J. P. Ables, their heirs and assigns, the certain lot of land situate in the City of Greenville County and State aforesaid, on the south side of East Court Street, being Lot 720.2 on plat made by R. E. Dalton, Engineer, December 1919, and having the following metes and bounds, to wit: Beginning at a point corner of present wall at the intersection of East Court Street and a court; thence with line of East Court Street S. 71-39 E. 101 feet 4 inches to a point at the North West corner of ten foot alley; thence with line of said alley S. 14-42 W. 54 feet 6 inches to point in line of Lot 720.1; thence with line of said lot N. 70-55 W. 101 feet 2 inches to a point in said line; thence S. 14-33 E. 53 feet 2 1/2 inches to the beginning corner. Also the strip of land commencing at the N.E. corner of said lot, running thence with the N. line of said lot in an easterly direction 5 feet to a point; thence parallel with the East line of said lot 54 feet 6 inches to a point in line of lot 720.1; thence westerly with said line to the S.E. corner of lot 720.2; thence with said line in a northerly direction 54 feet 6 inches to the beginning corner.

It is the condition of this deed that said alley be kept open as an alley for the use of the owners of the adjoining property covered by said plat.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee....hereinafore named, and their heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee....hereinafore named, and their heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, on this the 5th day of January, in the year of our Lord one thousand nine hundred and twenty, and in the one hundred and 44th year of the Sovereignty and Independence of the United States of America.
