 to me in hand paid at and before the sealing of these presents by E.W. Moon (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

E.W. Moon, all that piece, parcel or lot of land situated, lying and being in Greenville County and State aforesaid in or near the Town of Greer, S.C. on Frohawk Street, and having the following metes and bounds to wit:- Beginning on H.D. Timmons corner and runs along this line 210 feet to Hawkins line; thence along Hawkins line 203 feet to Edwards line thence along this line 209 feet to Frohawk Street; thence along Frohawk Street 202 feet to the beginning corner. And being the same lot of land conveyed to me by M.D. Littlefield by deed bearing date of October 26th, 1912.
