

J.A. Campbell DEED TO G.W. Morrow

KNOW ALL MEN BY THESE PRESENTS, That I, J.A. Campbell of Greenville County

in the State aforesaid in consideration of the sum of Fifteen Dollars \$15.00 DOLLARS, to me in hand paid at and before the sealing of these presents by G.W. Morrow

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

G.W. Morrow a certain piece or parcel of land situated being and lying in County and State aforesaid, being a part of what is known as the Carter Lister land, lying on South side of Middle Tyger River, being a portion of the land formally deeded to me from E.W. Barton, beginning on a Sweet gum tree running to River (North) thence down river to stone, thence South to stone, thence back to beginning corner, and containing one half acre more or less and bounded by lands of Mernerva Morrow Lands, G.W. Morrow, J.A. Campbell and J.J. Henson.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said G.W. Morrow, his heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said G.W. Morrow

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
