 beginning at a corner on old Spartanburg Road near pine tree at the corner of George Waddell's
 line S. 40° 00 E. 246 feet to corner near branch thence S. 57° 50 W. 94 feet to corner on
 Bettie Jones line & thence with her line 247 feet N. 40 EE to corner on Spartanburg road and
 thence with Old Spartanburg road 94 feet N. 57 - 50 W. to corner near pine tree containing
 half of an acre more or less. ✓
