DEED TO H.O. Jones

KNOW ALL MEN BY THESE PRESENTS, That We, W.D. Parrish and T.C. Gower of the

City of Greenville

in the State aforesaid

in consideration of the sum of Sixteen hundred and fifty DOLLARS,

to us in hand paid at and before the sealing of these presents by H.O. Jones

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

H.O. Jones, his heirs and assigns, all that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid and in the second Ward of the City of Greenville, BEGINNING at an iron pin on the south side of Whitsett Street at a point one hundred and ten (110) feet and five (5) inches west of Carolina Avenue corner of Lot "B" and running thence with Whitsett Street S. 76 45' W. fifty-five (55) feet and five (5) inches to an iron pin corner of lot "D", thence with line of lot "D" S, 15-0' E. one hundred and twenty-six (126) feet and one (1) inch to an iron pin on a ten foot alley, thence with said alley N. 76 45' E. fifty-five (55) feet and five (5) inches to an iron pin corner of lot "B", thence with line of lot "B", N. 15 0' W. one hundred and twenty-six (126) feet and one (1) inch to an iron pin on Whitsett Street, the beginning corner. The same being lot "C" of a sub-division of lots 3-4-5-6 Block 9, of Boyce's Addition to Greenville, as shown by plat of said lot as recorded in Plat Book "C", page 41, in the R.M.C. office for Greenville County.

Upon condition however which is a part of the consideration of this deed that the purchaser nor his grantee or grantees, heirs or assigns shall not erect a building costing less than \$1500. complete nor within fifteen feet from line of side walk abutting said property which condition is hereby declared to be a condition subsequent.
