in consideration of the sum of Five hundred DOLLARS, to me in hand paid at and before the sealing of these presents by

Ida J. Franklin (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Ida J. Franklin all that piece, parcel and tract of land situate, lying and being in Austin Township in the County and State aforesaid, adjoining lands of Isham McCrary, G.C. Franklin and others, containing twenty acres, more or less and having the following metes and bounds: Beginning on a stone on G.C. Franklins line; thence S. 34 W. 59.00 chains to a stone; thence N. 60-1/4 E. 8.00 chains to a stone; thence N. 34 E. 51.90 chains to a stone at road; thence N. 80 W. 3.90 chains to the beginning corner.
