KNOW ALL MEN BY THESE PRESENTS, That Coleman, B.S. Cox, John H. Nelson, J.J. Hitch, and John H. Jones, Deacons of the Baptist Church of Fountain Inn in the State aforesaid

in consideration of the sum of Seven hundred DOLLARS, to us in hand paid at and before the sealing of these presents by

Mary Abercrombie (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Mary Abercrombie, All that lot of land, lying, being and situate on the South side of Main Street in the Town of Fountain Inn, County and State aforesaid, the same being Lot No. 2, of a survey made by J.A. Adams for the Baptist Deacons of Fountain Inn Church and:

Commencing on iron pin corner of Lot No. 3, running; thence S. 53 W. 150 feet to an iron pin on alley, thence N. 37 W. 24 feet to an iron pin, corner of Lot No. 1, thence N. 53 E. 150 feet to an iron pin on Main Street, thence S. 37 E. 24 feet to beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Mary Abercrombie, and her heirs and assigns, forever.
