

E.W. Barton DEED TO J.A. Campbell

STATE OF SOUTH CAROLINA,

COUNTY OF Greenville

KNOW ALL MEN BY THESE PRESENTS, That I, E.W. Barton, of Greenville County and State aforesaid and in Highland Township it being in the State aforesaid in consideration of the sum of Fifteen hundred and fifty DOLLARS, to me in hand paid at and before the sealing of these presents by

J.A. Campbell (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J.A. Campbell, two lots or parcels of land situated, lying and being in Greenville County and State aforesaid, being my home tract of twenty acres, more or less lying on both sides of the Toogloo Road deeded to me from Ezias Dill, bearing date of January 2, 1908, recorded the 8th, day of November 1909 in Vol. 5, page 40 Audited the 8th, day of November 1909 in Book E. page 146.

Also a lot known as the Carter Lister old home place containing eleven & 3/4 acres, more or less, on waters of Middle Tyger Lot 1st, bounded by lands of John Crain, A.L. Campbell Shade Crain and Manerva Morrow. Lot 2nd, bounded by lands of J.J. Henson and Manerva Morrow. both lots contains 31-3/4 acres, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said J.A. Campbell, his heirs and assigns, forever.

AND I do hereby bind me and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said J.A. Campbell, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
