Hoke, Trustee of the estate of Frances C. Hoke, deceased all my right, title, and interest in so much of the property vested in me as Trustee by the order of Honorable John S. Wilson, bearing date the thirty-first day of March A.D. 1910, as has not heretofore been disposed of by me; my intention in executing this deed being specifically to convey to the said Grayson M. Hoke, Trustee as aforesaid, an undivided one-half interest in and to all that certain lot, piece, or parcel of land situate, lying and being in the State of South-Carolina and County of Greenville, in the Second Ward of the City of Greenville, having the following metes and bounds to-wit beginning at a stake on the east side of Main Street, between North Street and Oak Street, said stake being fifty-five (55) feet northward from the northwest corner of the land conveyed by Mrs. Aurelia T.
