WHEREAS, on the 28th day of June, A.D. 1912, P.S. Butler of Greenville County, S.C., was duly adjudged a bankrupt by the District Court of the United States, for the District of South Carolina, and L.K. AND WHEREAS, PROCEEDINGS were had on said Petition in accordance with the Bankruptcy laws of the United States in such cases made and provided, and the Petition coming on for a hearing at a meeting of the creditors of said Bankrupt on July 31st, A.D. 1912, notice of said meeting having been duly given to all creditors, both secured and unsecured—a Resolution was adopted, and an Order was made and signed thereon by J.J. McSwain, Esq., Referee in Bankruptcy, authorizing and directing L.K. Clyde, Trustee of said estate, to sell all the property of said Bankrupt estate not heretofore disposed of, according to the prayer of said Petition, and freed from all liens and incumbrances.

Richardson of a certain Note in writing for One Thousand Dollars with interest thereon from its date at the rate of 8% per annum until paid, on both principal and unpaid interest, executed on the 25th, day of Jan. A.D. 1911, by P.S. Butler to him, and, also, the mortgages ... securing said debt and note, dated respectively on the 25th, day of Jan. A.D. 1911 and the day of Feb. A.D. 1912, covering the 102 acre farm, first hereafter described and conveyed and lots 7 and 11 in "Melrose" and one-half acre of land, near Woodside Cotton Mills on New Cut Road, the said mortgages being recorded in the said Register's office, in Vol. 15, at page 83, and Vol. 17, at page 168; and, also, in the further consideration of the surrender and cancellation of a certain Note for Four Hundred and forty-three & 20/100 Dollars, executed to him by said P.S.
