KNOW ALL MEN BY THESE PRESENTS, That I, Sallie A. Greene, of the City of Greenville.
in the State aforesaid
in consideration of the sum of \$4000.00 Four thousand & 00/100 DOLLARS,
to me in hand paid at and before the sealing of these presents by E.D. Green

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said E.D. Green all of that piece, parcel or lot of land situated, lying and being in the Town of Greer, County and State aforesaid: Beginning at a stone on East side of Main Street at corner of Mill Street and running thence with Mill Street S. 13-1/2 W. 72 feet to a stone on said Mill Street at intersection of Victoria Street; thence thence with Victoria Street N. 77 E. (262) two hundred and sixty-two feet and (9) nine inches to a stone on said Street, corner of M.F. Wakefield place; thence with her line to a stone inside corner of her lot; thence with a straight line to a stone on Main Street; thence with Main Street to the beginning corner. Containing one acre, more or less and being the same tract of land conveyed to me by D.M. - Hendrix in deed bearing date 3rd, day of Feb. 1908.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said E.D. Green, his heirs and assigns forever.

AND I do hereby bind myself & my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said E.D. Green, -

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
