Coleman, A or tract of land To Wit corner on the old Road thence down sai 25 yd. thence strat across to the New Road, thence up said New Road to the Batson land and containing one and a half acres, more or less, it being all the land I own in said bound the same being on the Jones Gap Road leading from Marietta to Greenville City So. Ca.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Thos. E. Coleman, his heirs and assigns forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Thos. E. Coleman

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
