in consideration of the sum of eight hundred and thirty eight DOLLARS,
to me in hand paid at and before the sealing of these presents by H.A. Forrester

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said
H.A. Forrester one half interest in a certain piece of land that I bought this day from
J.C. Moon, containing forty five acres and the said H.A. Forrester is to enjoy full privileges
as I myself does in this land.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said H.A. Forrester, and his heirs and assigns forever.

AND I do hereby bind myself and heirs, executors and administrators, to warrant and
forever defend, all and singular, the said premises unto the said H.A. Forrester and his
heirs and assigns, against me and my heirs, and against
every person whomsoever lawfully claiming or to claim the same, or any part thereof.
