(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J.H. Glenn, all that piece, parcel or tract of land situate, lying and being in the State and County aforesaid about twelve and one-half miles north of Greenville C.H. in Bates Township, and on the east side of the Buncombe Road, bounded on the South by lands belonging to myself on the East by lands belonging to Frank Ferguson and E.W. Hart, and on the north by lands belonging to J.A. McCauley and the west by the Buncombe Road, containing fifty-two and 07/100 (52.07) acres, more or less.
