

G.P. Campbell DEED TO A. White

KNOW ALL MEN BY THESE PRESENTS, That I, G.P. Campbell

in the State aforesaid in consideration of the sum of Five Dollars and other good and valuable considerations, to me in hand paid at and before the sealing of these presents by

A. White (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

A. White, All that certain piece, parcel or lot of land, situated in the State and County aforesaid, same being a portion of Park Place and being known as lot No. 7, Block "P" as recorded in R.M.C. Office for Greenville County in plat book "A", page 119 and having the following metes and bounds to wit:-

Beginning at a stake on Third Avenue, joint corners of lot No. 6 and running thence with said Third Ave. N. 0-17 E. fifty feet to a stake, thence S. 89-45 W. one hundred fifty feet to a stake on a ten foot alley, thence with said Alley, S. 0-17 W. fifty feet to stake, thence N. 89-45 E. one hundred fifty feet to a stake, the beginning point.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said A. White, his heirs and assigns forever.

AND I do hereby bind myself & my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said A. White, his

heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
