J. J. Bohling DEED TO Mrs. Permelia C. Bohling

KNOW ALL MEN BY THESE PRESENTS, That J. J. Bohling of Greenville County in the State aforesaid in consideration of the sum of Three Hundred DOLLARS, to me in hand paid at and before the sealing of these presents by Mrs. Permelia C. Bohling of the State and County aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Permelia C. Bohling, her heirs and assigns, all of that certain piece, parcel and lot of land, situated in the State and County aforesaid, on Enoree River near Taylors Station on the Southern R.R. adjoining lands of Alfred Taylors Estate Southern Railway, J. J. Bohling and others, being the same lot of land purchased by me from Sarah Brown, Hattie S. Brown, W. M. Brown, and R. W. Brown by deed dated 25th Jan. 1912 and Recorded in registry of Mesne Conveyance Office, and having the following miles and bounds to wit: Beginning at stone J. Bohling corner. thence N. 69 3/4 E. 15.00 Chains to Enoree River thence up the said river as a line north 2.25 to iron pin on right of Way of Southern Railway thence with said right of Way N 84 1/2 W. 11.60 to iron pin, thence S. 23 1/2 E. 8.57 to the beginning corner, containing six acres more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.  
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Permelia C. Bohling her heirs and assigns forever.  
AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Permelia C. Bohling, her heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
