

Sillian S. McCrorey and Jones McCrorey DEED TO E. A. Gilfillin and S. B. Houston

KNOW ALL MEN BY THESE PRESENTS, That

we, Sillian S. McCrorey and Jones McCrorey now in the City of Greenville in the State of South Carolina in consideration of the sum of Ten Dollars and other Valuable Considerations

to us in hand paid at and before the sealing of these presents by E. A. Gilfillin and S. B. Houston (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

E. A. Gilfillin and S. B. Houston, their heirs and assigns forever: All our right, title and interest, in and to all that certain piece, parcel or lot of land, situate on the north side of East Washington Street, in the City and County of Greenville, and having the following metes and bounds, to wit: - Beginning at an iron pin on the corner of Washington and Mc Fee or Irvine Streets, and running thence with the line of last named Street and on the west side thereof N. 20- 3/4 E. one hundred and ten (110) feet, to an iron pin on a private Alley, fifteen (15) feet wide; thence with the line of said alley, N. 11 W. sixty-four (64) feet to corner of our lot, thence S. 20- 3/4 W. one hundred and ten (110) feet to corner on Washington Street sixty-four (64) feet, from the beginning corner; thence with Washington Street S. 71 E. 64 feet to the beginning corner, and being a part of the lot conveyed to the Grantors and Grantees herein, by the Piedmont Savings and Investment Company, by deed dated May 29th. 1915, and it is understood and agreed that the grantors and grantees herein, have established an alley fifteen (15) feet wide, in the rear of said lot, and that the same is to forever remain open for the exclusive use and benefit of the grantors and grantees herein named,

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

E. A. Gilfillin and S. B. Houston, their heirs and assigns forever.

AND we do hereby bind ourselves, our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

E. A. Gilfillin and S. B. Houston, their

heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
