KNOW ALL MEN BY THESE PRESENTS, That I, J.A. Dobbins

in the State aforesaid in consideration of the sum of Seven hundred and no/100 DOLLARS, to me in hand paid at and before the sealing of these presents by C.D. Dobbins

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said C.D. Dobbins, All that piece, parcel or lot of land situate, lying and being in the Courty and State aforesaid, near the Town of Greer and having the following metes and bounds: Beginning at a point on Morrow Street and running thence with said Street S. 11-1/4 W. 60 feet to the corner of lot No. 8; thence N. 78-3/4 W. 180 feet along the line of lot No. 8 to an iron pin; thence N. 11-1/4 E. 60 feet to the corner of lot No. 10; thence along the line of lot No. 10, 180 feet to the beginning corner, being known as lot No. 9 on a plat of land called Brookville.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.
