a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Thirty nine hundred (\$3900.00) DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee...
