KNOW ALL MEN BY THESE PRESENTS, That The Norwood National Bank of Greenville, S.C.

a corporation chartered under the laws of ~~xxxxxxx~~ United States of America and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Six thousand & 00/100 DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto...

W.P. Conyers, All that certain piece, parcel or tract of land, situate, lying and being in the County of Greenville, State aforesaid about four and one-half miles east of the City of Greenville, on the Scuffletown Road, containing one hundred and twenty-two acres, more or less, adjoining lands of T.F. Hunt, V. Perry Hudson, J.T. Jones, Walter Griffin, Jackson Brown, King Brown and others. Being the same tract of land conveyed to the said W.P. Conyers in two tracts by W.T. Henderson and the executors of the will of Jackson Brown, deceased respectively, and from the said W.P. Conyers to the grantor, by deed dated December 15th. 1911 and recorded in the R.M.C. office for Greenville County in Vol. 17, page 47.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee... hereinafter named, and... his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee... hereinafter named, and his heirs and assigns, against self and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

In witness whereof the said granting corporation has caused its corporate seal to be hereunto affixed and these presents to be subscribed by its duly authorized officers, J.W. Norwood, President and S.A. Moore, Cashier on this the 3rd, day of July, in the year of our Lord one thousand nine hundred and thirteen, and in the one hundred and thirty-seventh year of the Sovereignty and Independence of the United States of America.
