KNOW ALL MEN BY THESE PRESENTS, That Brandon Mills

a corporation chartered under the laws of the State of South Carolina and having its principal place of business in the State of South Carolina for and in consideration sum of Six Hundred and Fifty DOLLARS to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named, (the receipt whereof is acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

Columbus C. Dill, all that certain lot of land in the County and State aforesaid near Brandon Mills, represented on plat no. 2 of Brandon Mills Subdivision as lot no. 63; said plat being recorded in the W. M. C. Office for Greenville County in Plat Book page 77; said lot having the following lines, corners and distances: beginning at a stake, corner of Eastley Bridge Road and Jones Street, thence with Jones Street N. 33-45 W. 150 ft. to stake; corner of lot no. 70; thence S. 54 W. 47.7 ft. to stake corner of Lot no. 64; thence with line of lot no. 64 S. 33-30 E. 150 ft. to stake in Eastley Bridge Road; thence with Eastley Bridge Road, N. 61 W. 48.3 ft. to the beginning corner.
