KNOW ALL MEN BY THESE PRESENTS, That The Nowwood National Bank of Greenville

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville

in the State of South Carolina for and in consideration of the sum of Twenty Six Thousand three Hundred and forty DOLLARS

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto W. D. Parrish and T. C. Gowen

All that certain lot of land situate on the east side of South Main Street in the City of Greenville County and State aforesaid, more particularly described as follows: Beginning at a point on the east side of said Street, at center of a 17 inch brick wall corner of D. L. Norris' being 55 ft. from the southeast corner of South Main Street, and East No. Bee Avenue; and running thence with the center line of said 17 inch brick wall S. 70.01 E. 100 ft., thence N. 20.39 E. 24 ft. 2 inches to the center of a 12 inch brick wall; thence with the center of said 12 inch brick wall, N. 70.01 W. 100 ft. to a point on the east side of South Main Street; thence with the east side of said Street S. 20.39 W. 24 ft. 2 inches to the beginning corner. Being a portion of the land heretofore conveyed to the grantor by Sue Hedrick Earle

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantees hereinabove named, and their heirs and assigns forever.

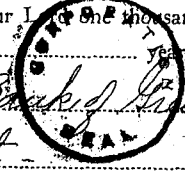
