KNOW ALL MEN BY THESE PRESENTS, That Camperdown Mills

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of fifteen hundred (\$1500.00) DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

A. E. Morris, J. R. Jenkinson, J. D. Fanna Hill, Hest M. Perry.
All that certain strip of land situate on the north side of Murphy Street, and being more particularly described as follows: Beginning at an iron pipe on the north side of Murphy street, corner of property now or formerly belonging to Parrish and Gower, said iron pipe being 19.3 feet east along Murphy street from the rear corner of Peick building situated at corner of South Main and Murphy Streets, thence along the north side of Murphy street S. 71-10 E. ten feet to corner of property belonging to Camperdown Mills, thence along line of said property N. 19-0 E. 118.6 feet; thence N. 72-0 W. ten feet to an iron pipe, thence S. 19-0 W. 118.5 feet along line of property of Parrish and Gower to the beginning corner. Said strip of land above granted to be kept open as an alleyway, the use thereof being reserved to the grantor, its successors and assigns, the grantees, their heirs and assigns and to the public generally.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the granteeS hereinabove named, and their heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the granteeS hereinabove named, and their heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
