in consideration of the sum of *Five Hundred* DOLLARS,

to *me* in hand paid at and before the sealing of these presents by *A. W. Harrison*

(the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

*A. W. Harrison, all that certain piece, parcel or lot of land situate lying and being in Greenville County, State of South Carolina, West of the City of Greenville and being a part of the City View property beginning at a stake corner of Smith St and New Cut Road and running thence in a northerly direction with Smith St one hundred and fifty feet or 153-6 to a stake corner of lot 10 thence with said line in a westerly direction sixty three feet to a stake; thence in a southerly direction with line of lot #11 a one hundred and fifty four feet six inches (154-6) to a stake on New Cut road thence in a westerly direction with said road fifty feet to a stake, at the beginning corner, same being lot #11 according to a plat of City View property said plat recorded in Office of R.M.C. for Greenville County.*
