KNOW ALL MEN BY THESE PRESENTS, That I, W.B. Hardin
in the State aforesaid
in consideration of the sum of One hundred, thirty-three and 30/100 DOLLARS,
to me in hand paid at and before the sealing of these presents by

W.N. Hardin (the receipt whereof
is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

W.N. Hardin, all my right, title and interest in all that certain tract of land on
Bald Rock Creek, Cleveland Township, County and State aforesaid, containing two hundred
and seventy (270) acres, more or less, and being the same tract, an interest in which
was conveyed to said Wm. B. Hardin by Mrs. R.M. Fines and B.E. Fines, by deed recorded
in Book "CCC", page 322, R.M.C. office and also by Mary A. Nolin, by deed recorded in
same book at page 323, reference to which description is here had for a full description
for this deed.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-
wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
W.N. Hardin, his heirs and assigns, forever.
