KNOW ALL MEN BY THESE PRESENTS, That I, Mrs. C.Y. Looper of Greenville County in the State aforesaid for and in consideration of the sum of two hundred and forty and 00/100 DOLLARS, to me in hand paid at and before the sealing of these presents by

D.G. Rosemond, of Greenville County, in the State aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

D.G. Rosemond, all that piece or parcel of land, lying and being in the State and County aforesaid on the west side of the Easley Bridge Road and being a part of the tract purchased from Millie Rosemond and having the following metes and bounds, to-wit:- Beginning at a white oak corner and running thence N. 71° E. 1.80 chains to an iron pin, thence S. 31-1/2° E. 7.00 chains to an iron pin, thence S. 47° W. 3.00 chains to a stake on Loopers line, thence with said Loopers line N. 42-1/2° W. 8.10 chains to the beginning corner and containing one and 60/100 acres, more or less.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said D.G. Rosemond, his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said D.G. Rosemond, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
