KNOW ALL MEN BY THESE PRESENTS, That I, Arizona G. Mahaffey

in the State aforesaid in consideration of the sum of Twenty-five DOLLARS, to me in hand paid at and before the sealing of these presents by Lee Bomar, B.B. Bomar and George Russell, as Trustees of the Mt. Zion Holiness Church, (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said Lee Bomar, B.B. Bomar and George Russell, as Trustees of the Mt. Zion Holiness Church, all that piece, parcel or lot of land, situate, lying and being in the State and County aforesaid, and having the following metes and bounds: Beginning on the corner of L. Jackson Green's line and runs thence along this line 124 feet to L. Jackson Green's corner; thence at right angles 10 feet to the corner of lot belonging to the Mt. Zion Holiness Church; thence with this line 124 feet; thence at right angles 10 feet to the line of L. Jackson Green, the beginning corner.

TOGETHER WITH, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Lee Bomar, B.B. Bomar and George Russell, Trustees of the Mt. Zion Holiness Church, their successors heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Lee Bomar, B.B. Bomar and George Russell, Trustees of the Mt. Zion Holiness Church, their successors heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
