 in the State aforesaid
 in consideration of the sum of \$200.00 Two hundred DOLLARS,
 to us in hand paid at and before the sealing of these presents by Sallie T. Stover (the receipt whereof
 is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Sallie T. Stover All that certain piece parcel or lot of land, situated, lying and being in
 the County of Greenville near the corporate limits of the City of Greenville, same being a
 portion of the City View property and having the following metes and bounds to-wit:
 Commencing at an iron pin on New Cut Road at corner of Hunt Street and running along New Cut
 road in a easterly direction 124 feet to alley, thence in a Northernly direction 75 feet to
 corner of lot 147, thence in a westernly direction along line of lot No. 147, one hundred and
 Sixteen feet to Hunt Street, thence along Hunt Street in a Southernly direction 53 feet to
 the beginning corner. Same being known as lot No. 146, according to a survey made of the City
 View property made by W.A. Adams, and being recorded in the office of Register of Mesne
 Conveyance for Greenville County.
