KNOW ALL MEN BY THESE PRESENTS, That I, A.C. Webster of Greenville, in the County of Greenville in the State aforesaid in consideration of the sum of One DOLLARS, (and natural love and affection for my son E. Agnew Webster, and other valuable considerations) to me in hand paid at and before the sealing of these presents by

E. Agnew Webster, (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

E. Agnew Webster: All that piece, parcel or tract of land in the County and State aforesaid, on the Laurens Road, near the City of Greenville, containing 35.83 acres, more or less, according to plat by Will D. Neves, dated Nov. 17, 1914, the lines of description in this deed includes a former conveyance by me to said E. Agnew Webster, of 75 acres, which is shown by dotted lines on plat above mentioned, and this deed is intended as an addition of adjoining lands to said 7.5 A. - heretofore conveyed to said E. Agnew Webster, making his tract aggregate 35.83 acres, having the following metes and bounds: beginning at an iron pin at rear corner of tract of E. Godfrey Webster, in a road; thence along his line N. 79 W. 312' to iron pin; thence N. 21-30 W. 780' to iron pin at joint corner of tracts of E. Godfrey Webster and R. Psyche Webster; thence along R. Psyche Websters' line N. 27 W. 290' to iron pin; thence S. 49-30 W. 573' to corner of R. Psyche Websters' land, iron pin and stone; thence S. 43-10 W. 1019' to iron pin, corner Mrs. A.C. Websters' tract; thence S. 46-50 E. 200' to iron pin; thence N. 53-30 E. 200' to cedar; thence S. 59-45 E. 329' to iron pin; thence S. 41 E. 336' to iron pin; thence S. 83-45 E. 309' to iron pin; thence N. 83-15 E. 412.5' to stone in fork of road; thence along road N. 31-30 E. 611.5' to beginning point at E. Godfrey Websters' corner.
