by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said D. R. Townes, all my undivided interest in and to all that certain tract of land situate in Greenville County in South Carolina, containing two hundred thirty three (233) acres, more or less, about four miles from Greenville east where our lying on Sabula River, being all the interest that I have in said lands which was conveyed unto me by said D.
