by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said G. N. Bell, All that piece, parcel or lot of land, situate lying and being in the State of South Carolina and County of Greenville and within the corporate limits of the City of Greenville and having the following metes, bounds, courses, and distances to wit: Beginning sixty feet from the South west corner of Frank Street and Key Street and running thence along Frank Street, S. 56° W. Sixty feet to an iron pin, thence S. 34° E. one hundred and thirty seven feet to an iron pin, thence N. 56° E. sixty feet to an iron pin, thence N. 34° W. one hundred and thirty seven feet to an iron pin at the beginning corner. Same being one of the lots conveyed to J. S. Hunt by Sarah N. Key, by deed bearing date September 4th. 1911, and from J. S. Hunt to me, by deed bearing date September 15th. 1911.
