(the receipt whereof is here-by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said E. S. Pleasants all that certain piece, parcel or lot of land, in Ward 2 of the City of Greenville, County and State aforesaid, on the southeast corner of Earle + Bennett Streets and having the following metes and bounds to wit: Beginning at a pin at Southeast corner of Earle + Bennett Streets and running thence with Earle St. S. 71-20 E. 60 feet to a pin, thence S. 18-30 W. 150 feet to a pin, thence N. 71-20 W. 60 feet to a pin on Bennett Street thence with said Bennett St. N. 18-30 E. 150 feet to the beginning point, and being a part of the same lot of land conveyed to me by W.
