(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Mills Realty Co., all that certain lot of land situate on the north-east corner of North and Laurene Street in Ward One in the City of Greenville, in the County of Greenville, and State of South Carolina, and having the following lines and bounds, to wit: - Beginning at the north-east corner of said North and Laurene Streets, and running thence in an easterly direction along North Street twenty-four (24) feet to a stake; thence in a northerly direction, along a line parallel with Laurene Street fifty (50) feet to a stake; thence in a westerly direction along a line parallel with North Street twenty-four (24) feet to a stake on Laurene Street; thence with Laurene Street in a southerly direction fifty (50) feet to the beginning corner; being the same lot of land hereinbefore described, to me by Charlotte R.
