KNOW ALL MEN BY THESE PRESENTS, That Hendrix Rector and State aforesaid in consideration of the sum of Five hundred and seventy-five and 00/100 DOLLARS to me in hand paid at and before the sealing of these presents by Anna P. Nichols

(the receipt whereof is here- by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Anna P. Nichols that certain tract or lot of land in Greenville County, State of South Carolina, known as lot No. 15 Block "A" as shown on a map of the Mountain View and Company survey of W. C. Adams, recorded in Plat Book "A," pages 396 and 397, and lot fronting sixty feet (60) on Buncombe Road and running back from a stake on the west side of Buncombe Road one hundred and seventy-two feet (172) to a stake on the east side of said road thirty-two feet (32) to a stake on the west side of said road one hundred and sixty-five feet (165) to a stake on Buncombe Road, joint corners lots nos. 14 and 15; thence with Buncombe Road sixty feet (60), being the same lot conveyed to S.
