KNOW ALL MEN BY THESE PRESENTS, That I, John King

in the State aforesaid, for and in consideration of the sum of Ten Dollars, and other valuable consideration to me paid by W.A. Bates

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W.A. Bates all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

in the city of Greenville, on the north side of Pendleton Street, between Wardlaw Street and C. & G Railroad tract, known as lot No. 1 in the subdivision of the lands of Thos J. Turner, deceased: Beginning at an iron pin on Pendleton Street and running thence N. 70 1/2 E. sixty-four feet to a stake; thence N. 19 1/2 W. one hundred one feet to stake; thence S. 70 1/2 W. sixty-four feet to an iron pin on an alley; thence S. 19 1/2 E. one hundred one feet to the beginning corner; being the same lot conveyed to John King, Stephen King and Joseph King by D.P. Varner, on the 4th day of December, 1893, deed recorded in office of Register of Mesne Conveyance for Greenville County in Book AAA, page 780.
