HAVE CERTIFIED over their signatures, Resolutions authorizing in behalf of the aforesaid Corporation an increase of the Capital Stock (authorized and set forth in the certificate aforesaid) to the sum of four hundred thousand (\$400,000.00),

which Resolutions were adopted pursuant to law, at a meeting of the stockholders of the aforesaid Corporation, of which thirty days' published notice was given, which notice stated the purpose of the aforesaid meeting, and further, that said Resolutions were adopted by a two-thirds vote, and that in all respects there has been complied with the provisions of Section 2795, Code of Laws of South Carolina, 1912, and all amendments thereto.

NOW THEREFORE, I, W. Banks Dove, Secretary of State, by virtue of the authority in me vested by Chapter XLVI, of the Code of Laws of South Carolina 1912,

and amendments thereto, and all Acts or parts of Acts me thereto enabling, have this day endorsed across the face of the aforesaid certificate of Incorporation or original Charter, authority of increase, as aforesaid, and I hereby certify that the requirements of law for said increase will have been complied with when this Certificate and the endorsement across the face of the original Charter aforesaid is lodged for record in the office of the Register of Mesne Conveyance or Clerk of Court in each County in which the said corporation shall have a business office

Whereas, pursuant to a resolution adopted by the Board of Directors of The Pelham Mills, a corporation created in and by an Act of the General Assembly of the State of South Carolina approved the 21st day of December A.D. 1882, entitled an Act to amend the Charter of The Pelham Manufacturing Company, and to incorporate the same under the name of "The Pelham Mills" was filed with me its petition for renewal and extension of the Charter of said corporation. Now, Know all men by these presents that the charter of said corporation, The Pelham Mills is hereby renewed and extended in perpetuity with all the franchises, powers, rights, privileges and immunities and subject to the responsibilities and liabilities heretofore granted to and imposed on such corporation.
