Westervelt and Albert M. Rickman hereinafter referred to as the Grantee (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released and by these presents does grant, bargain and sell and release unto the said Grantees that certain lot or parcel of land situate in the State of South Carolina, Greenville County. Each Grantee having respectively a one-half undivided interest in the said tract. That the property is not to be sold, or otherwise disposed of to persons of African descent. In event of a violation by the purchaser of the restriction above named, the title of this tract shall revert to the Grantor, except as against lien creditors.
