WHEREAS, in order to clear any defect in the title of the Board of Trustees of Chicora College in and to said property, the stockholders of Chicora College at a meeting held on the 7th day of December, 1915, in Columber, South Carolina, all the stock being held by the Board of Trust ees of Chicora College, and represented in such meeting, adopted resolution:

"That J. P. Marion as President, and S. C. Byrd as Secretary, respectively, of Chicora College, be, and are hereby authorized and directed to execute and deliver on behalf of said Chicora College to The Board of Trustees of Chicora College a deed of conveyance in fee simple in writing under the seal of Chicora College, conveying, in consideration of one dollar \$1.00, to said Board of Trustees of Chicora College and its successors all the real estate owned by Chicora College, in the City of Greenville, South Carolina in fee simple, inorder to carry out and perfect the title of The Board of Trustees of Chicora College in and to said property, which was heretofore directed to be conveyws to the said Board of Trustees by resolution of the stockholders of Chicora College, adopted at a meeting held in the City of Greenville, South Carolina, on July 30th, 1906."

## Pursuant to said resolution

NOW KNOW ALL MEN BY THESE PRESENTS: That Chicora College, a corporation organized under the laws of SouthCarolina, consideration of the sume of one dollar \$1.00 to it in hand paid.

Has granted, bargained, sold and conveyed, and by these presents does, grant, bargain, sell and convey unto The Board of Trustees of Chicora College.
