2. That she will indemnify and save harmless the Railway Company against any and all claims, demands, suits, judgments or sums of money accruing to the Licensee against the Railway Company, for loss of or injury or damage to said fence, or to any other property of the Licensee on said portion of said right of way so enclosed, which may be caused by fire set out by locomotives of the Railway Vompany, or for injury; to or destruction of any live stock which may stray from the said enclosed premises upon the tracks of the Railway Company.

3. That in the event that the Railway Company shall, at any time hereafter and during the life of this agreement, require for its railroad purposes the whole or any part of its right of way enclosed by said fence and occupied by the Licensee hereunder, then and in such event the Licensee will, upon thirty (30) days' notice, in writing, so to do, served upon her by the Railway Company, remove said fence from the right of way of the Railway Company, vacate said right of way and restore the same to its condition existing prior to the occupation and use thereof by the Licensee; or in default thereof, the Railway Company may itself re-enter upon said right of way, remove said fence and restore the said condition of said right of way, but at the expense of the Licensee.

And it is understood and agreed that the right of the Railway Company to revoke this license and require the Licensecand remove said fence and vacate said right of way by notice, as aforesaid, shall always obtain, nothithstanding the fact that the said premises may, at the time, be in cultivation, or may have growing crops thereon; the Licensee hereby specifically releasing unto the Railway Company the right to harvest crops which may be at the time of such termination growing upon said lands.

AND IT IS MUTUALLY COVENANTED AND AGREED:

4. That this agreement shall insure to the benefit of and be binding upon the respective successors, heirs and assigns of the parties hereto as well as upon the parties themselves.
