(1) That lot on College Street containing One (1) Acre, Two (2) rods and Thirty-two (32) poles, as follows: -Beginning at an iron pin on College Street at corner of lot now of E. W. Carpenter, formerly of Mrs. Jennie L. Goodwin, and running thence with College Street S. 67 E. 190ft.loinch, to an iron pin,
