VOL. 32. TITLE TO REAL ESTATE.

Whereas, W.H. Smith, late of the County and State aforesaid, died on the 10th day of April, 1916, leaving surviving him as his only he irs at law, his widow, Mrs. J.A. Smith, and his sons, B.Lee Smith and A.R. Smith, and his daughter, Ella King, and his grand-sons, Cromer Smith and Jonah Smith, the sons of his deceased son, R.S. Smith.

And Whereas, the said W.H. Smith left a paper purporting to be his last will and testement which is invalid under the laws of this State for the reason that it only has two subscribing witnesses thereto; and whereas by the terms of said purported will it was the intention and desire of the said W.H. Smith that his widow, Mrs. J.A. Smith should receive all the income from his property during her natural life-time, and whereas all of his heirs at law now desire that the intentions and the desire of the said W.H. Smith, as expressed in said purported will should be carried out as far as possible, except that it is agreed that J.T. Bramlett, the son of the said Mrs. J.A. Smith by a former marriage, upon her death shall come in and and share equally in all of the property of which the said W.H. Smith died seized and possessed, and that all of the Children and grandchildren of the said W.H. Smith shall come in and share in the tract of land containing forty-nine (49) acres, more or less, the legal title to which is in the said Mrs. J.A. Smith.

Now, Therefore, this agreement witnessed that we, the undersigned, do hereby agree that Mrs. J.A .-Smith, the widow of the said W.H. Smith, shall receive all the income from the property of which the said W.H. Smith died, seized and possessed, including the income from the tract of land which she has title to, for her support and maintenance during her natural life-time, she to keep all the taxes paid upon same and upon her death then all of the property of which the said W.H. Smith died seized and possessed and also the said tract of forty-nine acres, to which the said Mrs. J.A. Smith holds the legal title to, shall be sold and the proceeds of such sale shall be divided into five equal portions, that is to say, - B.Lee Smith to receive one-fifth thereof, A.R. Smith, one-fifth, Ella King, one-fifth, J.T. Bramlett, one-fifth and the remaining one-fifth to be devided equally between Cromer Smith and Jonah Smith.

It is further understood and agreed that the said B.Lee Smith is to assist Mrs. J.A. Smith as much as possible in the management of said property.

It is further understood and agreed that the money now on deposit in the Peoples National Bank of Greenville, S.C. to the credit of the said W.H. Smith, decessed, shall be paid to Mrs. J.A. Smith and so much thereof as may be necessary, be used by her in the payment of the funeral expenses of the said W.H. Smith, or any other debts that may be against said estate, and that the remainder be held by her for her own use.
