W.W. Beacham and C.E. Pritchette the free and uninterrupted use, liberty and privilege of and passage in and along a certain alley road or passageway on Poinsette Avenue in the City of Greenville:

"Beginning at a stake on the south side of said Poinsette Avenue 119,2 feet from Varmoy Street, themse S. 26-59 W. 172.5 feet to a fifteen foot alley, themse S. 63-01 E. with said alley 8 feet to a stake, thense N. 26-59 E. 172-2 feet to a stake on Poinsette Avenue, themse with Poinsette Avenue N. 63-01 W. 8 feet to the beginning corner.

Together with the free ingress, egress and regress, to end for the said C.P. Ballenger, W.W. Beacham and C.E. Pritchette, their heirs and assigns.

To have and to hold all and singular the privileges aforesaid to them, the said C.P. Ballenger, W.W. Beacham and C.E. Pritchette, their heirs and assigns, provided, however, that if the grentees herein should at any time close said alley by mutual consent that said alley shall revert to the grantor, his heirs or assigns.
