'(Bond for Title)'

State of South Carolina,

County of Greenville.

Know all men by these presents, That I, Francis A. Knight, of Greenville County, in the State of South Carolina, have agreed to sell to J.C. Edwards, of Greenville County, S.C. a certain piece, parcel or tract of land, situate, lying and being in the State of South Carolina, and County of Greenville, on branch waters of Beaverdam Creek, known as part of the Lemmel C. Dill tract of land, having the following metes and bounds, to-wit:

Beginning on a stone XOM, hear a spring, S.W. corner and running thence down branch N. 4-3/4 W.

17.43 to a bend; in branch; thence N. 13-3/4 E. 4.67 to a W.O. (gone), now a stone; thence N. 60 E.

5.70 to a hickory-stump, P.G. Green's corner; thence with P.G. Green's line to corner; thence with P.G. Green's line S. 72-4 E. 18.10 to a P.O. EXNM; thence S. 2-3/4 E. 18.20 to a stake NM; thence S. 86-4 W. 22.43 to the beginning corner, and containing forty-eight (48) acres, more or less, adjoining lands of P.G. Green, T.B. Powell and others.

Reserving a flight-of-way to the Public Road as the Old Road now stands, leading to the Cabin (house) on tract No. two (2), which is not to be included in this Bond for Title.

This being the same tract of cland conveyed to me, the said Francis A. Knight by Elizabeth Brookshire, by a deed dated 21st, day of october 1915 and recorded in the R.M.C. Office for said County and State in Deed Book # 38, at page 84, to which reference is hereby craved.

Upon the condition that Francis t. Knight is to pay all taxes thereon in the year 1917, and the said J.C. Edwards is to pay the sum of Twenty-four hundred (\$2400.00) Dollars for said land in the following manner.

one hundred (\$100.00) Dollars in cash upon the execution of this Contract and the balance (\$2500.00) due and payable on the first day of January 1918, with interest on same from maturity at the rate of eight (8%) per cent. per amum until paid, to be computed and paid annually, and if unpaid to bear interest until paid at the same rate as principal, and in case said sum or any part thereof be collected by an attorney, or through legal proceedings of any kind, then in addition the sum of ten per cent of the amount due thereon for Attorney's fee, and said J.C. Edwards having given his Note for the amount due as aforesaid.

It Is agreed that time is of the essence of this Contract and if said payments of every kind be not made when due, I the said Francis A. Knight shall be discharged in law and equity from all liability to make said deed, and may treat the said J.C. Edwards as tenant, holding over after termination or contrary to the terms of his lease, and shall be entitled to claim and recover, or retain if already paid the sum of all the money paid in this contract as a forfeit per year for rent or by way of liquidated damages, or may enforce payment of said Note.

The said Francis A. Knight, is to receive all the rents and profits made on the above land for the year 1917.
