Whereas, L. Alice A. Brooks, late of the County and State aforesaid, died leaving of force her last will and testament, dated January 30th, 1912, which was admitted to Probate in common form, by the Judge of the Court of Probate for Greenville County, on September 12th, 1912.

And Whereas, she appointed F.C. Thomason, executor of said will, who duly qualified, and entered upon the discharge of his duties as such executor.

And Whereas, the said F.C. Thomason, has since died, and W.D. League was on September 20th, 1916 duly and legally appointed as administrator with the will annexed of the said L. Alice A. Brooks. And Whereas, he has since that time, and is still acting in such capacity.

And Whereas, by the terms of said will, the said L.Alice A. Brooks, authorized and directed that her home-place, containing seventy-five (75) acres, more or less, hereinafter described should be sold. And Whereas, the same was duly advertised as required by law, and sold at public auction on sales day in October 1916, and the same was purchased by Marie Brooks and Gertrude Brooks for the sum of Six Thousand & no/100 Dollars.
