VOL. 33. AGREEMENTS, CONTRACTS, LEASES AND ETC.

(Agreement)

State of South Carolina,

County of Greenville.

This memorandum of agreement made and entered into between J.W. Moon, hereinafter known as lessor, and H.A. Graham, hereinafter known as lessee, at Greenville, South Carolina, this February 18th, 1917, Witnesseth:

That the lessor does hereby agree to lease unto the lessee all that house and lot and premises owned by lessee, located in the City of Greenville, State and County aforesaid, corner of MeMminger Street and Arlington Avenue, having thereon a new modern brick veneered house, for a period of three years, beginning with March 1st, 1917, and ending March 1st, 1920, upon the following terms and conditions:

That the lessee is to pay unto the lessor monthly the sum of thirty-three and one-third (\$33.331/3) Dollars at the end of each month during this lease. The lessor agrees to paint during the spring of 1918 the living room, dining room and halls, situate on the first floor of said house, in a proper manner, in such color, or colors as may be agreed upon between the lessor and lessee; the lessor is to pay for the labor and material for such painting.

The lessee is to furnish first class window shades for the house, throuthout, at his own expense, except that the lessor is to contribute the sum of ten dollars towards said shades, and they are to be the property of the lessor at the termination of the lease.

At the end of said period of three years, the lessor agrees to give the lessee the refusal of another lease, provided he desires to lease the same, the terms, however, to remain open, in as much as the lessee will have the privilege of leasing said premises before anyone else upon the best terms obtained from the lessor.

In the event of a fire, which may damage the building to such an extent that it will interfere with the occupancy of said premises, said lease shall be terminated.
