Know all men by these presents, That L.P. Jones, Administrator and S.L. Jones of said County and State in consideration of the premises, and of the sum of Forty-five & 00/100 dollars to us in hand paid by the City of Greenville, South Carolina, the receipt whereof is hereby acknowledged, do hereby grant unto the said City of Greenville, its successors and assigns, the right, privilege and easement to go in and upon that tract of land, situated in said County and State, bounded by lams of J.B. Bull on the north, Furman Roberts on the east, Batson estate and J.B. Johnson on the west and to construct and maintain in, upon, and through said premises, in a proper manner, with Poles, towers, wires and other necessary apparatus and appliances, lines for the purpose of transmitting power by electricity and telephone service, together with the right at all times to enter upon said premises for the purpose of inspecting said lines, and making necessary repairs and alterations thereon; together with the right to cut away and keep clear of said lines, all trees and other like obstructions that may in any way, endanger the proper operation of the same. The payment above specified is accepted in full settlement of all claims for said easement. Any damages to crops planted, shall be paid for at a price to be agreed upon, and if such can not be arrived at mutually, the damage shall be determined by arbitrators, one to be chosen by us, one by the holder of this grant, and the two so appointed, to select a third.

The decision of any two of the three arbitrators shall be final. The above right of way is granted for power line to be erected not less than fifty feet north-west of the rear of our barn- all wood on right of way to be cut, split & neatly corded on the above land. The above sum is based on fifteen poles & if more are erected, three dollars for each pole is to be paid in addition to above

Know all men by these presents, That we, Grove Station Lodge No. 166 A.F.M. of the County of Greenville, in the State aforesaid, in consideration of the facts set forth in the above preamble and the further consideration of five dollars to us in hand paid at and before the sealing of these presents by J.A. Norris, R.A. Dalton and Jas. E. Richey, Trustees of School District No.4-C of Greenville County (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J.A. Norris, R.A. Dalton and Jas. E. Richey, Trustees of School District No.4-C of Greenville County and their assigns and successors in office all of our undivided interest in that certain piece, parcel or lot of land situated, lying and being in Grove Township, State and County aforesaid, containing three-fifths (3/5) of an acre, more or less, lying on west side of National Highway at Grove Station and known as the Grove Station School property and described in the original deed as follows:
