Know all men by these presents That The Paris Mountain Water Company, a corporation chartered under the laws of the State aforesaid (hereinafter referred to as Grantor), in pursuance of resolutions of the stockholders and directors of said corporation duly passed at meeting called and held, respectively, on Mar. 21st and Aug. 1st, 1918, and in consideration of the sum of Eight hundred thousand (\$500,000.00) Dollars in bonds of the City of Greenville, South Carolina, to the Grantor in hand paid by said City, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the City of Greenville, the entire water plant belonging to the Grantor, including all buildings and structures, reservoirs, and pipe lines, and including all lends, rights of way, riparian rights, and other easements belonging to the Grantor and all supplies on hand on August 1st, 1918, and all other property belonging to the Grantor (save and except bills receivable and accounts receivable and other choses in action). All of said lands and property being situate and located in the County of Greenville, State aforesaid.

And the Grantor does hereby bind itself, its successors and assigns, to warrant and forever defend all and singular the said premises unto the City of Greenville, South Carolina, its successors and assigns, from and against the Grantor, and its successors and assigns, and all persons whomsoever lawfully claiming or to claim the same or any part thereof.
