

Sallie V.C. Fairchild DEED TO J. Harvey Cleveland, et-al. STATE OF SOUTH CAROLINA, COUNTY OF Greenville

KNOW ALL MEN BY THESE PRESENTS, That I, Sallie V.C. Fairchild of the City of Greenville, County of Greenville in the State aforesaid in consideration of the sum of Three thousand DOLLARS, to me in hand paid at and before the sealing of these presents by Mrs. Louise C. Gower and J. Harvey Cleveland (the receipt whereof is hereby acknowledged), have Granted, Bargained, sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said Louise C. Gower and J. Harvey Cleveland, All my right, title and interest in and to all that tract of land in Cleveland Township, devised to me by my father, J.F. Cleveland, by will filed in office of Probate Judge, Apartment 81, File 10, and being more particularly described as follows: Beginning on the upper line of the J.F. Cleveland tract where it enters the middle Saluda River, thence around back line of said land to a stone corner; thence S. 20 W. 68.50 to Buck corner on side Middle Saluda River on Jones Gap Road; thence up said river to the beginning corner on upper line, this is known as part of tract No. 3, and with it goes a piece of tract No. 1; Beginning in middle of Jones Gap road where lower line crosses said road, beyond school house; thence to head of Crowder Spring branch; thence down said branch to its mouth in Middle Saluda River; thence down said river to stake corner on bank of Middle Saluda River; thence with lower outside line of J.F. Cleveland tract to the beginning corner in middle of Jones Gap Road where lower and outside line crosses said Jones Gap Road, beyond school house, the 1/2 acre that is in bend of river, in the upper end of W.Y. Jones in the State aforesaid in consideration of the sum of ten dollars and other valuable considerations to me in hand paid at and before the sealing of these presents by W.D. Parrish and T.C. Gower (the receipt whereof is hereby acknowledged), have Granted, Bargained, sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said W.D. Parrish and T.C. Gower, All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid and in the Second Ward of the City of Greenville: Beginning at an iron pin on the south side of Whitsett St., at a point one hundred and ten (110) feet and five (5) inches West of Carolina Avenue, corner of lot "B", and running thence with said Whitsett Street S. 76-45 W. fifty-five (55) feet and five (5) inches to an iron pin corner of lot "D"; thence with line of lot "D" S. 15-0 E. one hundred and twenty-six (126) feet and one (1) inch to an iron pin on a ten foot alley; thence with said Alley N. 76-45 E. fifty-five (55) feet and five (5) inches to an iron pin corner of lot "B"; thence with line of lot "B" N. 15-0 W. one hundred and twenty-six (126) feet and one (1) inch to an iron pin on Whitsett Street, the beginning corner.
