This memorandum of agreement made and entered into this 23rd, day of April 1919 by and between Julia D. Charles, as Trustee for J.H. Charles, Sr., and S.B. Huff, both of the State and County aforesaid, W-i-t-n-e-s-s-e-t-h:

That for and in consideration of the sum of \$19,000.00, payable as hereinafter stated, Julia D.-Charles, as Trustee, agrees to convey to S.B. Huff by fee simple title a certain tract of land in Grove Township, State and County aforesaid, containing 243.123 acres, more or less, adjoining lands of J.P. Brashier, S.B. Huff, the Georgia Road and the New Cut Road, consisting of two tracts conveyed by J.L. Rhodes to John Henry Charles by deed dated January 17, 1918, and recorded in Volume 50, page 26, the two tracts containing 242.79 acres, more or less, and one-third of an acre, more or less, respectively.
