(the receipt whereof is here- by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said M. R. Garrison all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina and County of Greenville, in Gantt Township, about eight miles from the City of Greenville, adjoining lands now or formerly belonging to John Harbin, Henry L. Bell, B. F. Arnold, W. C. Garrison and others; the tract of land hereby conveyed having the following metes and bounds, to-wit: Beginning at a stone on road and running thence N. 2° E. 17.35 chains to corner of land conveyed by me to Ben Arnold (see deed book No. 13, page 209); thence along line of said land N. 82° W. 5.70 chains to a stake on corner of land conveyed by George W. Arnold to B. F.
